## ORDINANCE NO. /6-08-01

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS RELATING TO GAMING PARLOR LIQUOR LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §111.19 of the Village of Code of the Village of McLean is hereby amended by adding a new subsection 111.19 (G) which is as follows:

#### §111.19 (G) CLASS G-GAMING PARLOR.

- (A) A Class G license shall only be issued to a video gaming parlor, which is hereby defined as an establishment or business whose primary purpose is to operate video gaming terminals, as defined under the Illinois Video Gaming Act and in which the sale of foods or snacks and alcoholic beverages are only incidental to the operation of the video gaming terminals.
- (B) A Class G licensee may not sell beer or wine unless the licensee has a valid license from the State of Illinois to operate video gaming terminals, as defined under the Illinois Video Gaming Act.
- (C) A Class G license shall authorize the sale at retail of beer or wine by the drink for consumption on the license premises.
  - (D) The fee for a Class G license shall be \$1,000 per year.

SECTION 2: §111.12 of the Village Code of the Village of McLean is hereby amended by adding, in proper alphabetical order, to the chart contained within that section the following additional information:

Classification		Annual Fee	Number of Licenses Authorized
Class G	(Gaming Parlor)	\$1,000	0

SECTION 3: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 4: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 5: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
