BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN, MCLEAN COUNTY, ILLINOIS:

#### SECTION 1:

Ordinance No. 16-07-11, which was an ordinance appropriating the sums of money necessary to defray all expenses and liabilities of the Village of McLean, McLean County, Illinois for the fiscal year of May 1, 2016 through and including April 30, 2017 is hereby amending by deleting SECTION 5 and substituting in place thereof the following SECTION 5:

SECTION 5: Section 11-74.4-55(j) of the Tax Increment Allocation Redevelopment Act requires the Village to include in its annual budget certain information regarding the Village's tax increment finance district for the proceeding fiscal year. Specifically, the Village is required to set forth in its annual budget the revenues generated from redevelopment project areas by source and the expenditures made by the Village for redevelopment project areas.
