AN ORDINANCE AUTHORIZING THE SALE OF PERSONAL PROPERTY

WHEREAS:

(1) It is the opinion of at least a majority of the Trustees then holding office in the Village of McLean that it is no longer necessary or useful or for the best interests of the Village of McLean to continue to own and keep the following described personal property:

Red, 2002 Ford F550, 4 wheel drive truck with an automatic transmission and an electrically controlled dump with a steel 11 foot bed. The vehicle is equipped with a 6.8 liter V-10 engine and with approximately 129,836 miles.

(2) Whereas 65 ILCS 5/11-76-4 authorizes the Village of McLean to sell personal property that is no longer necessary, useful to or for the best interest of the Village to continue to own.

- The item of personal property described in the foregoing paragraph 1 of the foregoing recitals was advertised for sale pursuant to authority granted by the President and Board of Trustees of the Village of McLean.
- Sec. C. It is no longer necessary or useful or for the best interests of the Village of McLean to continue to own the item of personal property described in paragraph 1 of the foregoing recitals.
- Sec. D. Based upon the proposals received for the purchase of the property described in paragraph 1 shall be sold to BENTIEL MOTO 25 for a parchase price of \$ \$ 5000.

 Sec. E. This Ordinance shall be in full force and effect from and after its passage and approval in
- the manner provided by law.
