#### ORDINANCE NO. <u>21-02-01</u>

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 95-5-6A OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS RELATING TO NUMBERING OF CHAPTERS IN TITLES XIII: GENERAL OFFENSES AND XIV: DRUG OFFENSES

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

<u>SECTION 1</u>: Chapter 140 of Title XIV of the Village of Code of the Village of McLean is hereby amended in the following manner and method:

Chapter 140 shall hereby be renumbered to be Chapter 145, and \$140.01 - \$140.99 shall be renumbered as \$145.01 - 145.99. The Index of the code shall be likewise updated to reflect the renumbered Chapter and Sections.

<u>SECTION 2</u>: Chapter 141 of Title XIV of the Village Code of the Village of McLean is hereby amended in the following manner and method:

Chapter 141 shall hereby be renumbered to be Chapter 146, and \$141.01 - \$141.99 shall be renumbered as \$146.01 - \$146.99. The Index of the code shall likewise be updated to reflect the renumbered Chapter and Sections.

SECTION 3: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 4: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 5: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
